Objetivos generales		
Este curso desarrollará una comprensión de sistemas biota-tierra, desglosando los efectos de la geología y geomorfología sobre la biota como su transformación por la misma. Se presenta un bosquejo de la biodiversidad y los biomas, su geografía y relaciones con la superficie de la tierra e introducciones a diversos métodos de estudio.
